

Downtown Development Authority 2018 Romulus Farmers Market Rules, Regulations and Vendor Application For Consideration

Market Dates: Every Wednesday June 13th – September 26th 2018. 11:00am – 4:00pm at the Romulus Historical Park Pavilion located at 11147 Hunt Street, Romulus, MI 48174.

ALL VENDORS MUST BE SET-UP AND READY TO OPEN BY 10:45 AM

- In order to promote Michigan's economy, the Romulus Farmers Market is open to Michigan Artisans, Farmers and Producers. All produce must be grown within the State of Michigan. Produce vendors may supplement with U.S. grown produce during the month of June ONLY.
- Vendor fees are based on 10' x 12' spaces at the rates noted below. Vendors must supply their own tent, table, chairs and electricity if needed.
- Vendors must clearly display merchandise prices as well as the name and location of business at each booth.
- Vendors must comply with the MDARD Rules and Regulations.

- The Market Manager reserves the right to assign vendor space. Vendor spaces will be assigned prior to the start of the season and remain the same throughout the market season. Seasonal rate vendors will be given preference over daily rate vendors. **If seasonal spot space is not occupied by 10:45am, daily rate vendors may temporarily occupy an empty space.**
- Each vendor booth must be under supervision of a responsible representative 18 years or older. Children under the age of 18 must be accompanied by an adult at all times during the market. This is for their safety.
- Market will be held rain or shine. Closure of the Market due to threatening weather or an emergency situation is at the discretion of the Market Manager.
- If you are unable to participate in the market on any given day, you MUST contact the Market Manager as soon as possible or a \$5.00 charge will be levied.
- The Market Manager and the DDA reserve the right to reject a vendor application if the Market Manager's judgment, the goods and merchandise are not compatible with the overall concept of the market, or fails to comply with the rules and regulations of the market.
- **ABSOLUTELY NO VEHICLES PARKED NEAR OR AROUND THE VENDOR BOOTHS.** All vendor vehicles must be parked in the designated parking area located north of the market area.
- A vendor that attends 8 or more markets will be offered a space during the Pumpkin Festival at a discounted rate.
